Getting Berlin climate neutral by 2050



- Coalition agreement: "Getting Berlin climate neutral by 2050"
- Berlin has to reduce its CO₂ emissions over the next years to around 4.4 million tons a year (2050)
 - Reduction by 85% compared to the base year of 1990.
 - Milestones are a 40% CO₂ reduction by 2020 and a 60% CO₂ reduction by 2030

Capital city of Germany and one of the 16 German federal states

Administration


- Central administration with Senate departments and 12 districts
- Currently Left/Green Government

Population

- Population: about 3.7 million
- High population growth, forecast:4 million by 2030

Economy


- GDP 2017 at 136.1 billion €, growth (3,3%) above German average of 2.2 %
- Mainly service sector, also creative industries, research, media and IT, tourism (9 million visitors per year)




Status-Quo of Energy Supply



- Lowest per inhabitant emission in Germany
- Central and large scale CHP (60 % of energy production)
- Substantial coal substitution since 1990, no lignite since 2017, phase-out coal till 2030
- Renewables only marginal (electricity & heat)
- Major emission source: Buildings (private, industry, services)
- The city is an energy sink in a region with >50% renewable electricity generation





Energy consumption





Challenges

- Stagnant trend of CO₂ emission reduction (-32 % since 1990 but constant since 2011)
- High percentage of fossil energies
- Urban area, limited space for expansion of renewable energies



Opportunities

- Role of cities in climate policy increasingly acknowledged
- Lot of flexibility options (e.g. heating networks, power-to-x-technologies)
- Place for innovative ideas with strong European and international ties
- High readiness for behavioural change (e.g. sharing economy)

Lead interest

- Can Berlin become climate neutral?
- Which requirements have to be fulfilled?

Tasks

- Analysis of CO₂-emissionen & reduction potentials
- Recommendations for a climate protection path
- Measures and lead projects

Results (2014)

- 85 % Emission reduction possible
- 2 possible scenarios
- Linking electricity & heat sector by using excess electricity
- Large potential for solar energy (PV and thermal)
- Recommendations of action for each of target area
- Regional effects on the economy

Energy Turnaround Law Berlin (EWG)



Purpose

• Makes climate targets and their instruments **legally binding** (40 % until 2020, 60% until 2030, 85 % until 2050 compared to 1990)

Role model public authority

- Remediation Roadmap for Public Buildings
- Action Plan on Carbon Neutral Administration
- Compilation of energy and emission balances for each bourough

Further content

- **Energy:** Climate friedly energy production and supply for public buildings
- Climate Protection Agreements with industry and companies
- Climate protection as educational content
- Climate Adaption: Developing strategies and measures, implementing climate change monitoring

Berlin Energy and Climate Concept (BEK)



Procedure

- Based on feasibility study "Climate Neutral Berlin 2050"
- Drafting of concept is obligatory by law (§ 4 EWG)
- Thorough public participation process
- Draft of BEK by a scientific research consortium

Function

- Shows specific strategies & measures
- Central instrument for implementing energy turnaround law with timeframe until 2030

Elements

- Contains 100 specific measures addressing mostly city policy and to some extent German national policy
- Cost assessment for each measure
- Details of measure implementation responsibilities and jurisdictions.

Energy Policy in Berlin





- Phase-out coal and decrease other fossil energies
- Expand gas-fired, flexible cogeneration
- Densification of head grids (heat storage)
- Massive extension of solar energy
- Expansion of heat pumps and geothermy
- Power-to-X-technologies, virtual power plants, flexibility options
- Promote urban business models

- Two Senate Departments on Climate Protection and Energy
- Senate Departement for Economic, Energy and Public Enterprises is responsible for several measure of the BEK, mainly in the field "energy".
- Primary focus on support of decentralized renewable energy generation
 - Enlarge sector coupling and flexibilization
 - Increasing availability/usability of public roofs
 - Support PV-generation on tenements with local consumption
 - Masterplan Solar City







Masterplan Solarcity Berlin - A Variety of Measures to Guide Solar Growth in the Capital of Germany.











Solar thermal

- feed-in and energy system in Germany neglects small and decentralised photovoltaic systems and specific need of urban areas
- secure investments
- Convincing participants and mobilising financial resources
- Enable the use of self-produced energy in a city
- Tenant-Landlord-Challenges


Masterplan Solarcity Berlin



Main tasks

- Identification of potential (public, private, sectors)
 www.energieatlas.berlin.de
- participation process to involve relevant stakeholders
- Identify specific measures and targets for different stakeholder groups
- Completion until Summer 2019 (Start in November 2018)





Nut Shell

- 25% of Energy supply can come from solar
- ~ 450.000 buildings that could be used (~320.000 housing)
- Masterplan "Solar City" with 27 measures for various actors
- Unit to control implementation, Continued monitoring
- Constant expert exchange

1. Information, Consultation, Public Relations





Increase the installation of solar energy by

- generating awareness
- improve the image of solar energy
- free consultation

Stakeholder are important partners for the implementation of measures.

Implementation of some measures have started.



- Opening of an information center for solar energy in May 2019
- Cooperation with the German Society on Solar Energy (DGS)
- Main tasks of the solar center Berlin will be:
 - Consultation on solar energy including on-site visits, assistance in the evaluation of offers
 - Information services for craft companies, architectures and engineers
 - Presentation of best practice examples
 - Trainings and qualification programs






Internet Platform "Solarwende Berlin"

- Launch of a new internet-platform about solar energy in May 2019
- Target group specific information, communication, education and advice
- Motivate stakeholders to invest in decentralized renewable energy generation.

2. Overcoming barriers





- Improvement of the **grid connection** process of solar systems.
- Finding solutions for installing solar systems on buildings under monumental protection.
- Improve the **knowledge of the employees of local authorities**, f. e. about combination of solar systems and green roofs.

3. Increasing Profitability of Solar Systems





- Improve the profitability of solar systems through **funding**, e. g. programs for power storages or "PV readyness".
- A funding for power storages like battery storages or hydrogen storage systems, if they are installed with a PV system, will be implemented in 2019.



4. Supporting Market Initiatives



- Support tenants and residential property
 owner associations by finding a way to
 realize a solar system on their property.
- Developing a website for supplying roofs to companies for the installation of solar systems.

5. Strengthening Market Actors



- Strengthening the solar industry and solar installers in Berlin.
- Strenghening academic programs and academical research in renewable energy.




6. Agreements with Stakeholders



 Agreements with companies and institutions on supporting the Solar City Berlin.

7. Role Models



- Installing solar systems on public buildings
 (e. g. schools, governmental buildings)
- Promoting solar energy by communicating best practices for optimal solar performance.

8. Creating a Better Legal Framework





- Identify legal barriers and opportunities.
- Starting **federal initiatives** in the Bundesrat (Federal Council) adressing the following topics:
 - 52 GWp limit for PV growth
 - Better conditions for Landlord-to-tenant electricity
 - Taxes and tariff offsets for rewneable energy, carbon-pricing
- Legal check of requirements of solar panels on new and homes and existing buildings

Next Steps



- "Expertenkreis" decides to support most of the measures in June 2019
- Last meeting of the "Expertenkreis" in August 2019 → Final decision on the koncept ("Expertenempfehlung")
- Senate decision in summer 2019
- Implementation of measures have already started
