### The Need for Public Solar NYC



### Limited Uptake of Solar Resources by NYC Households

A robust ecosystem of solar installers, operators, and financing options has developed across New York State – but NYC has not benefitted proportionately from this growth


- Low-income homeowners in disadvantaged communities have disproportionately experienced negative impacts of climate change and are being left behind in the clean energy transition.
- 1-4 family residential buildings have the highest potential to benefit from installing solar PV on rooftops.

### **Objective & Goals**

PSNYC aims to reduce barriers to solar adoption for low-income homeowners and renters in New York City and is guided by the following overarching goals.

#### **PSNYC Goals**

- Increase access to solar for NYC residents not adequately served by the current market;
- Serve as a centralized one-stop shop for holistic services for 1-4 family solar installations;
- Effectively deliver the program using federal SFA funds, while setting the program up for long-term financial stability beyond the grant period;
- Deliver 20% household savings to participants, in line with Solar for All funding requirements; and
- Generate good-quality green jobs in the residential solar deployment space in NYC.



### **Program Components**

PSNYC aims to accelerate the deployment of solar for low-income New York City residents, increasing access to solar for both owners and renters who are missed by the current or expected market.

**Three Program Components of PSNYC** 

1. Public Leasing Program for 1-4 Family Homes	2. Community Solar for Multifamily and/or Commercial Buildings	3. Program for Solar Enabling Upgrades
NYC special purpose entity (SPE) subsidizes solar installation and offers <b>affordable solar panel leases</b> (low or zero-interest) to qualified 1-4 family homeowners.	NYC SPE creates a <b>community solar</b> <b>program</b> using rooftops in identified buildings (public or private) offering an affordable subscription fee to LMI participants.	NYC SPE provides <b>grants</b> to qualified buildings for solar-enabling upgrades – i.e., roof repairs and electrical work – so the building is ready for solar installation.







### **Completion of Solar Projects**


The SPE's ability to complete solar projects requires it to execute various contracts with vendors, all of which are overseen by full-time employee managers, who are employed under PSNYC by the SPE.



### **PSNYC** Roles

Given that no single entity is capable of conducting all of the work required for PSNYC, the program needs to procure strong partners depending on market interest.



### **Note on Federal Funding**

Public Solar New York City (PSNYC) is currently funded through Solar for All (SFA), a program administered by the US Environmental Protection Agency as part of the Federal Inflation Reduction Act. In October 2023, the City, in collaboration with NYSERDA, supported the New York State application for SFA. As a result, PSNYC was awarded \$37.5 million in SFA funding.

The City is closely monitoring the federal government funding situation. Unless significant changes are made to SFA funding by the new administration, the City is committed to moving forward with PSNYC program implementation through the processes described in this presentation.



### **Note on Labor and Wage Standards**

#### **PSNYC** Tasks

#### - 1. Marketing and Customer Acquisition

Questions focusing on best practices on outreach and customer acquisition including customer journeys to ensure a smooth process from inquiry to installation.

#### · 2. Designing Scopes of Work -

Questions focusing on 1-4 family solar design, solar make-ready home repairs, and contracting.

#### - 3. Execution of Scopes of Work -

Questions geared towards solar installers about the solar installation process, their comfort and preferences related to City bulk purchase and ownership of panels, and labor and wage standards.

### **RFI Structure**

Respondents can provide responses to any or all of the RFI sections, organized by PSNYC tasks. Given the range of PSNYC tasks, the RFI is designed in a way to allow for many vendor types to provide valuable input into program design.

#### **PSNYC** Tasks

- 4. Equipment Maintenance and Asset Management

Questions focusing on solar installation maintenance and lease management.

#### **5. Project Management, Coordination, and Customer Relations**

Questions focusing on how implementation partners may provide coordination support across PSNYC operational tasks and if they provide education of solar and technical assistance to PSNYC customers.
